Travel Conditions (Summary)

● When registering, please be sure to read these Travel Conditions (Summary) as well as the complete Terms and Conditions of Travel provided separately. Registration will close once all available spots are filled, so please apply as early as possible.

(1) Recruitment-Type Tour Planning Contract

● This tour is planned, recruited, and operated by Hankyu Travel Service Co., Ltd. (Registration number with the Commissioner of the Japan Tourism Agency: 1847) (hereinafter referred to as "the Company"). Customers participating in this tour will enter into a Recruitment-Type Tour Planning Contract with the Company.

(2) Registration Method

● Please register for this tour by phone, internet, or other means. (Some tours may also accept registration by mail, fax, or other communication methods.)

● After registration, we will send you payment instructions.

(3) Formation of the Tour Contract

● The Tour Contract between the customer and the Company is formed when the Company commits to entering into the contract and receives full or partial payment of the tour fees.

(4) Registration Requirements

● Please register with a group of 2 or more people (except for some tours that accept single registrations).

If one person cancels after two people have registered due to the customer's own reasons, an additional single room supplement fee will be charged.

● Customers requiring special care, such as those with chronic illnesses, those currently in poor health, pregnant women, disabled individuals, or those requiring the use of assistance dogs are required to inform us of your situation at the time of registration. The Company will cooperate to the extent possible and reasonable. In addition, any expenses incurred for special measures taken by the Company at the customer's request will be borne by the customer. You may also be required to submit a doctor's certificate or a designated "Explanation Form."

(5) Payment of Tour Fees

● The full tour fees must be paid no later than 21 days prior to the departure date. However, for tours that require separate payment of a deposit and the remaining balance, the deposit must be paid within 3 days after receipt of the remittance notice specified by the Company, and the remaining balance must be paid no later than 14 days prior to the departure date. Remittance fees shall be borne by the customer.

(6) Items Included in the Tour Fees

● The fees cover transportation costs, accommodation expenses

meal fees, tour operation handling charges, tour leader expenses, and tips required for group activities as explicitly listed in the tour itinerary. If any of the above-mentioned services are not utilized due to the customer's personal reasons, no refunds will be issued.

(7) Items Not Included in the Tour Fees

● Except for the items listed in (6) of the preceding article, all other expenses are not included in the tour fees. Some examples are as follows:

*Personal items such as telegrams, phone calls, and beverage fees during meals

*Fees for optional tours (such as additional small-scale excursions) that are only available to those who wish to participate and are charged separately.

*Round-trip transportation costs from your home to the meeting point and the dispersal point, as well as expenses during free time.

*Medical expenses incurred due to accidental injuries or illnesses.

*Domestic travel comprehensive insurance premiums (Voluntary insurance)

(8) Cancellation Fees

● If a customer cancels the trip for personal reasons after registration, the following cancellation fees will be charged per person based on the total tour fees.

● If a customer changes the departure date or itinerary for personal reasons, the following cancellation fee provisions will also apply.

● If a customer changes the travel content such as sightseeing spots, hotels, or transportation for personal reasons, please understand that no refunds will be issued for the relevant expenses.

● The cancellation acceptance date shall be based on the time when the Company confirms receipt of the customer's cancellation application during business days and business hours.

● The Company's Liability and Exemption Clauses

The Company will provide compensation if it causes damage to

customers due to its own reasons. However, the Company shall not be liable for damages caused by the following reasons:

- Damages caused by natural disasters, earth changes, or other force majeure events
- Damages caused by the customer's violation of laws, regulations, or public order and morals
- Damages caused by responsibilities outside the Company, such as transportation or accommodation institutions

● In the event of a significant change as described in Article 23 of the Terms and Conditions of Tour, a change compensation fee equivalent to 1% to 5% of the total tour fees will be paid based on the content of the change, in accordance with the provisions of the Recruitment-Type Package Tour Contract; however, the total change compensation fee paid for a single Tour Contract shall not exceed 15% of the tour fees. Furthermore, if the change compensation fee for a single Tour Contract is less than JPY 1,000, no change compensation fee will be paid.

(9) Cancellation of the Tour Contract and Suspension of Tour Departure by the Company

● When the number of customers does not reach the minimum number required for the tour as stated in this contract documents, the Company may suspend the implementation of the tour. In this case, the Company will notify the customers no later than the 13th day (inclusive) before the departure date of the tour and refund the full amount of the tour fees already paid by the customers.

(10) Confirmation Document (Final Travel Itinerary)

The Company will deliver this document to you no later than the day before the departure date of the tour. (In principle, efforts will be made to deliver it 5 days before the departure date of the tour.)

★ Please note that this itinerary may be subject to changes in the itinerary or sightseeing spots due to arrangements by transportation agencies and local conditions etc.

(11) Handling of Personal Information

● For information on how the personal information provided by customers is handled, please refer to "Handling of Personal Information" at the end of the Terms and Conditions of Tour.

● Under no circumstances will the Company provide a travel re-implement service. For matters not stipulated in these Conditions, the Company's Standard Terms and Conditions for the Tourist Industry (Recruitment-Type Tour Planning Contract) shall apply. 

